### **Company Secretary's Report**

Adrian informed the meeting that he had been contacted by David Goose to request that EEMC continues to subscribe to the Assoc of North East Midlands Motor Clubs (£25 pa) so that the club can continue to be a means of David competing in motorsport events. This was agreed.

### **Treasurer's Report**
